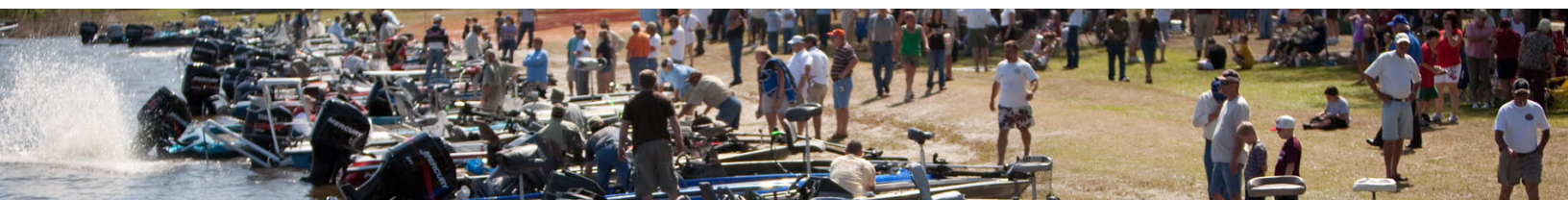

### TOURNAMENT RULES

- Each participant is responsible for abiding by all local, state, and federal rules which may apply to this tournament. Winter Haven Hospital Foundation and Ron's Tackle Box, LLC are not responsible for enforcement.
- Participants should stay (50) yards away from another boat when their anchor is down.
- Boat lights must be on during dark hours or foggy conditions.
- No culling at the ramp!
- No Live bait allowed.**
- Fish **MUST BE** weighed in **BEFORE** boat is loaded on trailer.
- (5 FISH LIMIT)** Each fish **MUST BE 14" MINIMUM** mouth closed to tail - **Golden Rule.**
- Any dead fish weighed in will result in a penalty of 4 oz. per fish.
- Any participant weighing in a short fish will be disqualified.
- Any protests **MUST BE** made **BEFORE** weigh in.
- Only one pole per person to be used at a time.
- Weigh-In Time is 1:00 pm.**
- Boats can be launched from any lake on the chain. Please boat over to **Lake Shipp for tournament start at SAFE DAYLIGHT.**
